

## BY-LAWS OF THE CURRY COUNTY CRUISERS CAR CLUB

- I. **Purpose:** The purpose of this club shall be to help preserve, promote and encourage the enjoyment of all special interest automobiles. Also, as a club, to provide and regulate special events such as cruises, swap meets, picnics, tours, etc. for all club members and their families. This club is also formed with all car enthusiasts in mind and to promote skillful and courteous driving on all public highways and to work to defeat legislation that may be harmful to all automobile hobbies.
- II. **Membership:** Any individual who expresses interest in the preservation, enjoyment and restoration of any special interest auto, not limited to any year or manufacturer, may apply for a membership application form and remitting the proper amount of dues applicable at that time.
- III. **Dues:** Annual dues shall be \$20.00 per year payable the ~~Third Tuesday~~ **second Sunday** of January each year. New members shall pay \$20.00 when joining any time during the first quarter, \$15.00 during the second quarter, \$10.00 during the third quarter and \$5.00 during the fourth quarter. Any member who has not paid dues for the previous year shall be considered a new member. Any member 60 days in arrears shall be dropped from the membership.
- IV. **Meetings:** Monthly meetings shall be held on the ~~Third Tuesday~~ **second Sunday** of each month, unless one of these dates fall on a holiday: **time and place to be set at the previous month's meeting.** Board members shall meet once each month with the date to be set at one of the monthly meetings. All members are welcome to attend all board meetings. Also, special meetings may be called by the board upon request of seven or more members.
- V. **Board of Directors:** The offices of President, Vice President, Secretary, Treasurer and the Editor shall constitute the Board of Directors and these offices shall be decided upon by a vote of members of the club. Should a board member become unable to perform their duties or resign, a new board member shall be appointed by a vote of the club members. The term of office for each position shall ~~not exceed~~ **be** two consecutive years. Nominations and elections shall be at the November meeting of even years. Prospective candidates shall express their willingness to serve before their names are submitted.
- VI. **Duties of the Directors:**
  - President:** Conduct all business meetings, appoint committees (to include a nominating committee in OCTOBER) and assist the other directors.
  - Vice President:** to assist the President and conduct all meetings in his/her absence.

**Secretary:** To record minutes of the meetings, take care of club correspondence and maintain the membership roster.

**Treasurer:** Receive and disburse funds, keeping a full account of all monies.

**Editor:** collect and prepare a newsletter to keep members informed of all club matters.

**VII. Committees:** Committees are on a voluntary basis, or appointed by the board of directors as they deem necessary.

**VIII. Newsletter:** A newsletter shall be published to inform members of the club and member news, current and timely events, etc.

**IX. Parliamentary Procedure:** Robert's Rules of Order shall be the **final** authority **for disputes** on all matters not covered in the by-laws.

**X. Dissolution:** In the event of dissolution of this club all remaining assets of the club known as Curry County Cruisers shall be donated to a worthwhile charity considering all outstanding bills are paid.

Any member who does not agree with the purpose of this non-profit organization shall make their views known at a regular meeting of the board of directors.
